CHAMBERSBURG, Nov. 21, P. M.—It is rumored here that Governor Wise has received a despatch from Governor Chase of Ohio informing him that a large body of men from 200 to 1,000 are coming to that State for a purpose of Brown, and that they will undoubtedly start for Chambersburg. Gov. Wise is said to have replied that if he allowed them to cross the line he would order proceedings against him on the charge of treason. A despatch was received on Saturday also from U. B. Marshall Johnson, of Ohio, stating that from 600 to 1,000 men were coming for the purpose in that State. John Brown, Jr., Commander.

MOVEMENTS AT THE TABORS.—Washington, Nov. 22.—The Tabors Gray, City Guards and Bealy Ridge Rifles, leave for home in the regular evening boat. The Artillery have not arrived, and it is supposed they will be detained all the evening. The Orange and Alexandria and Central Railroad Officials have been notified to make preparations for the first regiment, which are expected here on this evening.

WASHINGTON, Nov. 22, 9 P. M.—The Petersburg Battalion, except the Artillery, are here and leave for home this evening. Only the Howitzer company of the First Regiment are to be dispersed with at Chambersburg. They have just arrived, and return to Richmond to-night, via the Orange and Alexandria and Central route. At the latest accounts Chambersburg was all quiet, but it is believed that only the presence of a large military force has prevented an attempt to rescue the prisoners.

WASHINGTON, Nov. 22.—Marshall Johnson denies giving information of a large body of men preparing to cross to Virginia. MARSHALL'S PRISON, Nov. 22, P. M.—Gov. Wise had sent here stopping with Col. Barlow Superintendent of the Army.—The Governor stated that he has made every provision to protect the prisoners and the community. He has no doubt of a determined and thoroughly organized movement throughout the Northern States to rescue Brown and exhibit several letters from responsible parties in Pennsylvania and Ohio urging him to be prepared, for parties were forming in those States. The Blues go to Martinsburg to-night, and Col. Smith, of the Military Institute, with Cadets and Howitzers, has been ordered to Chambersburg.
