Mr. A. A. Douglas. Judge DOUGLAS has written a pamphlet of twenty-four pages in reply to Judge BLACK's "Observations." It is a very worldly document, and printed in the style of Black Republican clap-net electioneering speeches. Its temper is not the sweetest nor its tone the most elevated, but it is at least free from the fulsomeness and indignation directed at the public at Worcester.

Of course we have no intention of trying our hand at a criticism of Judge DOUGLAS's Reply. But we wish to say a few words about his oft-repeated charge of "misrepresentation." When Mr. Douglas set down to write a twenty-four page pamphlet to correct alleged "misrepresentations," he should have taken care not to permit a "misrepresentation" to creep in to the first paragraph he indited. In the very first paragraph of his Reply—after referring to his publication in Harper's Magazine and explaining its object—he indulges in the following deliberate misrepresentation of fact: "A few weeks afterwards an anonymous review of my article made its appearance—first in the Washington Constitution and subsequently in pamphlet form." Now the fact is, Judge BLACK's review appeared first in pamphlet form and subsequently in the Constitution. And of this fact Mr. Douglas could not have been ignorant when he wrote his Reply, for when the Constitution transferred Judge BLACK's review to its columns on the 10th of September, it said: "A large portion of our paper to-day is covered with the republication of the masterly pamphlet on Senator DOUGLAS's Popular Sovereignty." It had, we think, previously announced its intention to lay the pamphlet before its readers.

This may seem to be an unimportant misrepresentation on the part of Senator DOUGLAS. But there is more in it than appears on the surface. The car who DOUGLAS's barking have more than once accused Judge BLACK of being a sort of editor of the Washington Constitution, and DOUGLAS has stooped to deliberate misrepresentation to give a color of truth to the false accusation.

Mr. DOUGLAS quotes the vote of the old Congress on JEFFERSON's plan for the government of the Territories, to prove that Judge BLACK erred in saying that the old Congress had rejected that plan. He claims to have pointed out this error in his Worcester speech, and finds fault with the Judge for not correcting it in the Appendix to his Observations. Judge BLACK did not make the correction in his Appendix, but he did make it in the body of his Observations before the second edition was issued, as Mr. DOUGLAS can see for himself by referring to page thirteen of the enlarged pamphlet. So this attempt to convict the Judge of suppressing the truth falls as all similar attempts have failed and must fail.

Judge DOUGLAS winds up his windy Reply by advising "Judge BLACK and his confederates" to "cease their energies and direct all their efforts to the redemption of Pennsylvania from the thralldom of Black Republicanism," and to let the immaculate Little Giant alone. This is refreshingly cool, coming from the man whose indecent behavior towards a Democratic administration revived the nearly defunct Black Republican party in Pennsylvania, and whose speeches have been published with approbatory comments by the Republican journals. If DOUGLAS had stood firmly by his party, instead of voting with SEWARD and WILSON in the Senate, there would be precious little left of Black Republicanism in Pennsylvania. It is responsible for the defeat of the Democracy, and they will hold him to a strict accountability for it.
